He is also co-editor (with Martin H. Greenberg) of two collections of science fiction stories: **Give Me Liberty** and **Visions of Liberty** (both published by Baen Books). He has also been a featured speaker at seminars in the USA, London, Canada, Australia, Hong Kong, Singapore and elsewhere, and has appeared on TV and radio all over the world.

Since 1991, in addition to helping start five new (and highly successful) investment publications, he has been a marketing consultant and acted as a counsellor. A graduate in economics from the Australian National University, he began a PhD program in economics at UCLA. He is also a Master Practitioner of Neuro Linguistic Programming.

He also coaches investors who want to transform their investment results -- and works on improving his tennis game..


